1. Alabama Department of Revenue

Get a listing by county of tax delinquent properties currently in State inventory and complete an online application to buy one of these “left over” liens from the state.

2. Arkansas Commissioner of State Lands

In Arkansas, tax sales are handled by the state, not by local government. They do allow bidding by mail; however, it is advantageous to be at the auction since bids received by mail are announced immediately preceding the live auction of the parcel.
